## IN PENNSYLVANIA TODAY:

- There are approximately 1.8 million people with disabilities<sup>1</sup>
- There are approximately 2.4 million people ages 65 and older<sup>2</sup>

## The Better Care Better Jobs Act Invests in Cost-Effective Services

Cost of Home Care Per Person/Per Year	Cost of Congregate Care Per Person/Per Year
\$26,000 <sup>4</sup>	\$90,000 <sup>5</sup>



## OVER 16,000 PEOPLE IN PENNSYLVANIA ARE ON THE WAITING LISTS FOR SERVICES<sup>6</sup>

The Better Care Better Jobs Act would provide over 120,000 more seniors and people with disabilities with needed services in Pennsylvania<sup>7</sup>

## THE BETTER CARE BETTER JOBS ACT WOULD CREATE

Over 19,000 new home care jobs in Pennsylvania and raise wages for care workers—the median wage is under \$12 per hour<sup>8</sup>
