### The Republican Plan for Medicaid Will Harm Rhode Island

More than <u>300,000</u> Rhode Islanders rely on <u>Medicaid</u> and the Children's Health Insurance Program (CHIP).

# Republican Cuts to Medicaid Put Rhode Islanders' Health and Coverage At-Risk

Every proposal on the Republican <u>wish list</u> of more than \$2 trillion in Medicaid cuts is bad news for Rhode Islanders. Medicaid cuts would harm children, older adults, and families, ripping away their health care access and coverage. Republican Medicaid cuts would:

Cut Care for Children. Around 37% of children in Rhode Island are enrolled in Medicaid or CHIP. Around 47% of kids with special health care needs, such as a physical or behavioral disability, rely on Medicaid in Rhode Island. Cuts would disproportionately hurt children with the lowest incomes and the highest health care needs.

**Block Access for Pregnant Women and Newborns.** Nearly 4,250 births (43%) in Rhode Island per year are covered by Medicaid. A cut to Medicaid would prevent mothers and babies from getting the care they need.

Increase Disparities for Communities of Color. Around <u>53%</u> of children and adults with Medicaid in Rhode Island are people of color. A decrease in Medicaid funding would reduce access for the communities that need it the most.

Curb Health Care Access for People with Disabilities. Medicaid covers nearly 60,000 people with a disability in Rhode Island. Only 44% receive Supplemental Security Income,

meaning many do not qualify for Medicaid on the basis of their disability and could be subject to Republican policies like work reporting. People with disabilities often depend on Medicaid for services in order to thrive in their communities.

Create Barriers to Behavioral Health Services. More than 22,500 Medicaid beneficiaries were treated for a substance use disorder in Rhode Island in 2021. Medicaid cuts and eligibility restrictions threaten lifesaving treatment for people with behavioral health needs.

### **Cut Coverage for Medicare Beneficiaries.**

Nearly <u>50,000</u> dually-eligible Rhode Islanders rely on Medicaid to help pay their Medicare premiums and co-pays. For these enrollees, a cut to Medicaid is a cut to Medicare.

**Disrupt Nursing Home Care.** Cuts to Medicaid could disrupt care for <u>64%</u> of nursing home residents in Rhode Island who use Medicaid to pay for care in a nursing home.

### **Bottom Line:**

Republican proposals to cut Medicaid will result in Rhode Islanders losing Medicaid coverage—and there is no acceptable coverage loss. No Medicaid cuts to Rhode Islanders to fund tax handouts to billionaires.
